## FINANCIAL POLICIES

---

The operation of Bethel Christian Academy relies on the payment of tuition by the students. The School Committee will insure proper use of financial resources.

### PARENT FINANCIAL AGREEMENTS/PAYMENT PROCEDURES

Parent Financial Agreements will be signed by the parents/guardians upon admission/re-enrollment of the student to BCA. All tuition is assessed as an annual fee due but may be paid annually, semiannually or monthly.

- **Annual** payments are due in **June**.
- **Semi-annual** payments are due in **June** prior to the school year and **January** of the same school year.
- **Monthly** payment plans begin on **June 1** prior to the start of the school year and end on **May 1** of the following year.
- Payments that are not received by the 5th of the month will be assessed a \$25.00 late fee.
- Payments that are not received by the 10th will result in the student not being allowed to attend classes until the past due amount has been paid.
- Family maintenance fees are due by October 1 of the school year or may be added to the tuition for the monthly payment plan.
- Curriculum fees are assessed by grade levels and are due based on the date published with the yearly Tuition and Fee Schedule.
- Any discounts allowed are outlined in the yearly Tuition and Fee Schedule.

### TRANSFER

If a student transfers to BCA from another school, during the current school year, their tuition will be prorated for the number of months remaining in the school year. The enrolling month will be considered as a full month no matter the number of days attending.

### WITHDRAWAL/REFUND POLICY

All tuition and fees are non-refundable. All tuition is due yearly with no refunds or release from financial obligation for students who are dismissed or withdraw early. Students enrolled for the upcoming school year must be withdrawn prior to May 31 or the parent/guardian is responsible for June and July payments. Exceptions will be made for major changes in circumstances such as: relocating 50+ miles, substantial loss of income, or other unforeseen circumstances as approved by the school committee. Any request for release from financial obligation must be made in writing to the Business Administrator who will forward it to the school committee. Parents/Guardians may be required to meet with school committee members. By signing the Financial Agreement, you are authorizing BCA to withhold report cards and other records until tuition and other fees have been paid in full.
